Whilst disclosing our risk exposures on a standalone basis for our head office and branches in Japan, overseas branches, overseas offices, SPCs, and major subsidiaries in the data book till 2Q of the year ended March 31, 2021, we have decided to disclose our risk exposures on a consolidated basis covering all affiliated companies, starting from the fiscal year ended March 31, 2021.

In line with this update, the reporting has been expanded to cover all countries including major developed countries, while the timing of release has been rescheduled taking into account the time required for its compilation.
